**Materials are accepted** in English, Spanish, Portuguese and Ukrainian languages.

The book (collective monograph) will be published with **ISBN**, indexing in **Google Scholar** and with the assignment of each author's scientific section **DOI**, which will allow authors to find their research work on the Open Ukrainian Citation Index (OUCI).

**For the publication of materials in the book (collective monograph) the authors should:**

2. Send to e-mail [monograph@reicst.com.ua](mailto:monograph@reicst.com.ua) scientific materials for the publication.
3. Send to e-mail [monograph@reicst.com.ua](mailto:monograph@reicst.com.ua) a copy of payment receipt. Requisites for payment are sending after the materials receipt.

For chapters with authors of Universidade Estadual do Oeste do Parana, Campus Toledo, Brazil, the publication of materials is free of charge. Reimbursement of expenses for correction, editing, page proofs of the book (collective monograph) is **UAH 1200 (US\$32) for 20 pages**. The cost per each

additional page is **UAH 25 (US\$1)**. **If desired**, the author can order additional a printed version of the book/monograph, a cost per copy is **UAH 500 (US\$14)**. Upon request, each participant has the opportunity to receive a certificate regarding the implementation of research results within the framework of the Center's scientific projects. This certificate is subject to a separate fee of **UAH 650 (US\$18)** ([link](#)).

**Requirements for pages layout:**

- author's material must be an integral scientific material, including findings of original researches of the author;
- length of the chapter not less than 20 pages and the maximum of 40 pages; paper size A4 with spacing 1,5; Font type Arial, size 12; margins on all sides – 20 mm; without hyphens, automarkers and autonumbering;
- bibliography/ references used is indicated in the order of mention or in alphabetical order (in APA style (APA Style Reference Citations according to the sample <https://drive.google.com/file/d/15em-ySdJbNVt79dl83dJkChjg5PFjKsa/view> ));
- formulas and symbols should be typed in formulas editor MathType 6.0 or Microsoft Equation 3.0 as a separate object, all components of the figure must be grouped;
- all figures and tables must be editable.

**General structure of the author's material:**

- last name and first name of the chapter's author; scientific degree and academic title, position, place of work (each co-author from a new line); city of author(-s); title of the chapter; abstract of 7-10 sentences in the language of the chapter (indicate the issues and results of the research). If the material is submitted in Portuguese, Spanish or Ukrainian, the abstract is submitted in English;
- the material should have the following structure (*with the selection of elements and their names*): short introduction (Introduction) and review of the literature (Literature Review) (1-2 pages), 2-3 sections equal in volume, conclusions (Conclusions) (up to 1 page ), bibliography (References) in APA style (at least 10 sources);
- the review of the literature in the text should contain a specification of scientific results that formed the basis for the study;
- Bibliography/ References should be placed after the author's material in textual order or in alphabetical order in APA style.

**Plagiarism Policy and Academic Ethics:**

Authors who have submitted materials for publication must agree with the following provisions:

- the author is responsible for the accuracy of the information provided and compliance with the requirements of integrity in his work;
- the authors retain all copyrights and at the same time give the collection the right of first publication, which allows to distribute this material indicating the authorship and the original publication in this collection;
- in case of violation of scientific ethics by the author (s) Coordinators reserve the right to reject materials without additional explanations and obligations.
